

#### **DATA OWNER APPLICATION FORM**

#### 1. General Information

Personal Data Protection Law no. 6698 ("PDP Law") has granted personal data owners the rights to learn whether their personal data are processed, to request information if their personal data are processed, to learn the purpose of processing the personal data and whether they are used in compliance with the respective purpose, to know the third persons to whom their personal data are transferred at home or abroad, to request correction if their personal data are processed incomplete or inaccurate manner, and request that the third parties such data are transferred to are informed on the transactions within this scope, to request deletion, disposal or anonymization of personal data if the reasons for processing are eliminated although they are processed in accordance with the provisions of Law no. 6698 and other related laws, and request that the third parties such data are transferred to are informed on the transactions within this scope, to object to any unfavorable circumstances arising from the analysis of personal your data exclusively by means of automated systems, and to claim for damages if they suffer loss as their personal data are not processed in accordance with law.

As per the first subclause of Article 13 of Personal Data Protection Law, any applications to Teknopanel Çatı ve Cephe Pan. Ürt. San. ve Tic. A.Ş. (hereinafter referred to as "Company") as a data controller should be submitted with this Data Owner Application Form in written or other methods determined by Personal Data Protection Board ("Board").

## 2. Method of Application

For applications within this scope, this form may be printed and submitted to our Company in written as follows:

- Application of the applicant in person,
- Notification via public notary,
- With the Applicant's "secure electronic signature" as defined in Electronic Signature Law no. 5070,

and sending to our Company's registered electronic mail address. Written application channels and information to be specified while submitting applications are given in the table below.

## 3. Situations Outside the Scope of Application Right

As per Article 28 of PDPL, it is not possible for personal data owners to exercise their application rights as the following situations are outside the scope of PDP Law:

- Personal data are processed for research, planning and statistical purposes by anonymization with official statistics.
- Personal data are processed for the purposes of art, history, literature or science or within the scope of freedom of speech, provided that they do not violate national defense, national security, public safety, public order, economic safety, right of privacy or personal rights or do not constitute a crime.
- Personal data are processed within the scope of preventive, protective and informative activities by public institutions and organizations appointed and authorized by laws for ensuring national defense, national security, public safety, public order or economic safety.
- Personal data are processed by judicial or execution authorities in connection with investigations, proceedings, jurisdiction or execution procedures.

As per subclause 2 of Article 28 of PDP Law, it is not possible to exercise application rights in the following situations, except the right to claim for indemnification of loss:

- Personal data processing is required for prevention of crimes or for criminal investigation,
- Personal data made public by the data owner are processed,
- Personal data processing is required for fulfilment of audit or regulation duties and performance of disciplinary investigations or proceedings by public institutions and organizations appointed and authorized by laws or professional organizations serving as public institutions,
- Personal data processing is required for economic and financial interests of the government in connection with budget, tax and other financial issues.

# 6. Our Company's Method and Duration of Replying Applications

As per Article 13 of PLP Law, our Company shall finalize the application requests of data owner within the shortest time according to the qualitied of the request -within 30 (thirty) days at the latest- and free of charge. Moreover, it may charge the data owner based on the tariff determined by the Board if the procedures require additional costs.

For the purposes of ensuring the security of your personal data, our Company may request information from the data owner for determining identity and authority.

The applicant of data owner may be rejected in the following situations:

- (1) It prevents rights and freedoms of other persons
- (2) It requires unproportioned efforts
- (3) The information is open to public
- (4) It puts others' confidentiality at risk
- (5) One of the situations outside the scope of PDP Law exists
